INDEPENDENT AUDITOR'S REPORT

To the Unitholders of Stanbic IBTC Ethical Fund

Report on the Audit of the Financial Statements

OpinionWe have audited the financial statements of Stanbic IBTC Umbrella Fund ("the Fund"), which comprise:

- the statement of financial position as at 31 December 2021;
- *the statement of infancial position as at 3.1 December 2021;
 *the statement of comprehensive income;
 *the statement of changes in net assets attributable to unitholders;
 *the statement of cash flows for the year then ended; and
 *the notes, comprising significant accounting policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Fund as at 31 December, 2021, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs) and in the manner required by the Financial Reporting Council of Nigeria Act, 2011.
