

Terms and Conditions

- The maximum subscription amount permissible on this platform is N200,000.00.
- The minimum subscription amount permissible on this platform is N5,000.00.
- In the event that the Net Asset Value of your investment in the Mutual Fund exceeds N200,000.00 (Two Hundred Thousand Naira) either by appreciation of the investment or by additional subscription(s) to the Mutual Fund, you would be able to top up your investment account.
- In the event that the Net Asset Value of your investment in the Mutual Fund exceeds N200,000.00 (Two Hundred Thousand Naira) either by appreciation of the investment or by additional subscription(s) to the Mutual Fund, you would not be able to execute a redemption on the investment account unless the account is upgraded (See below upgrade process).

 - A Passport photograph.

 - Proof of Address (kindly find below acceptable proof of address documents):
 - Recent utility bill such as PHCN and Water Board,
 - Current driver's licence issued by FRSC,
 - Bank statement or passbook containing current address,

 - Confirmation from the electoral register that a person of that name lives at that address,
 - Solicitor's letter confirming recent house purchase or search report from the Land Registry,
 - Search reports on prospective client's place of employment and residence signed by a senior officer of the Capital Market Operator.
